## Purpose

The essential purpose  
of the Park District is as follows:

1. To be familiar with the park and recreation needs of the Park District's residents, and as much as possible, to meet those needs.
2. To accept the responsibility for providing adequate and attractive park areas and wholesome leisure opportunities for all people of the Park District within the limitations of the money provided through collection of taxes, gifts and funds from other sources.
3. To make the best possible use of all physical facilities under the direction of the Board as well as those made available to it by other agencies in the District.
4. To cooperate with all other groups, including schools, churches, and other public and private agencies, and with state and national groups, to offer leadership in coordinating and correlating all those activities and services to obtain maximum benefit to the citizens of the Park District.
5. Park and recreation lands should be acquired even if the limited financial resources of the park and recreation agency oblige it to delay complete development.

To enrich the quality of life of our community by providing leisure opportunities for people to learn, play and grow.

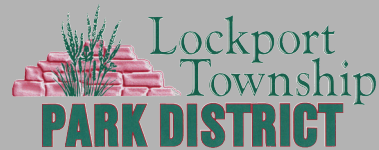

## Freedom of Information Act, Illinois State Statute 5 ILCS 140/1-140/11.5

Current meeting agendas and minutes can be accessed on the District's website. A separate form is not required to access records; however, a form is available on the website or at the Administrative Offices for this purpose. All requests for records can be made in writing to one of the District's FOIA Officers.

When making a request, please be specific and indicate:

- The name, address and daytime phone number or e-mail of the person making the request;
- A description of the records or information being sought
- If the information being sought is for a commercial purpose;
- How you would like the information to be provided to you (e-mail, U.S. mail or held for pick-up at our office).

Allow up to 5 business days for a response.

Please indicate if your request is for a commercial purpose, If so, the Park District provides access to the records and/or copies of them within 21 business days. It is a violation of the Act for a person to knowingly obtain a public record for a commercial purpose without disclosing that it is for a commercial purpose.

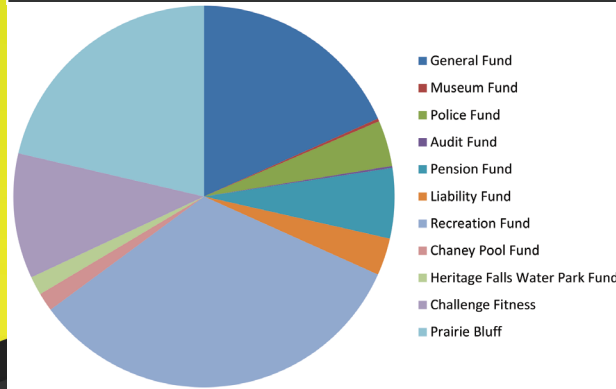

### Operating Budget by Source



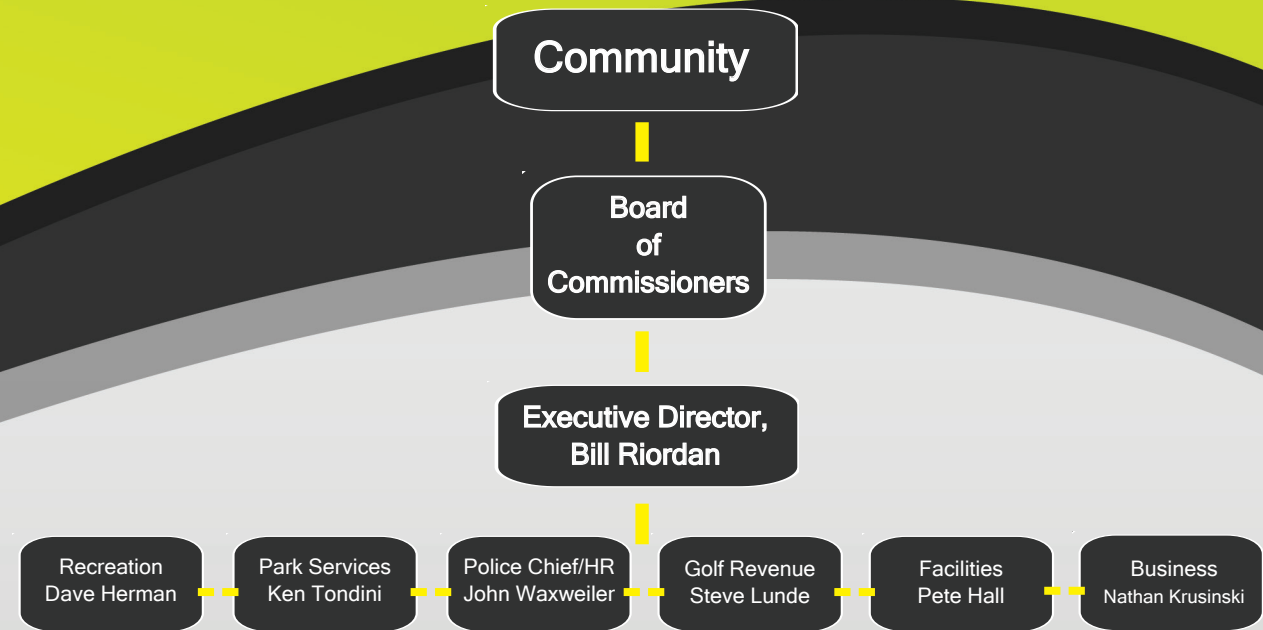
